Security is the top priority for Indian Railways, and all possible developments are checked on a regular basis to prevent mishaps and improve protection. This includes basic tool repair, such as the replacement of over-matured equipment. the collection of suitable advances for track, moving stock, flagging, and interlocking frameworks up-gradation and support, health drives, a greater emphasis on authority preparation, and security examinations at regular intervals to screen and instruct staff for recognition of safe practices. In 2017-18, the 'Rashtriya Rail Sanraksha Kosh (RRSK)' fund was established with a corpus of Rs.1 lakh crore over a five-year period for basic security-related works with an annual cost of Rs.20,000 crore. RRSK spent Rs.16,091 crore on track renewals, Rs.18,023 crore on road over/under bridges, signaling and telecom works, and Rs.16,091 crore on rolling stock in 2017-18 and 2018-19, respectively. In Budget Estimates for 2019-20, a cost of Rs.20,000 crore has been allocated to RRSK (Bandyopadhyay, N. 2018).

Preventive and prescient upkeep of the Railway resources is attempted to guarantee safe train activity.
