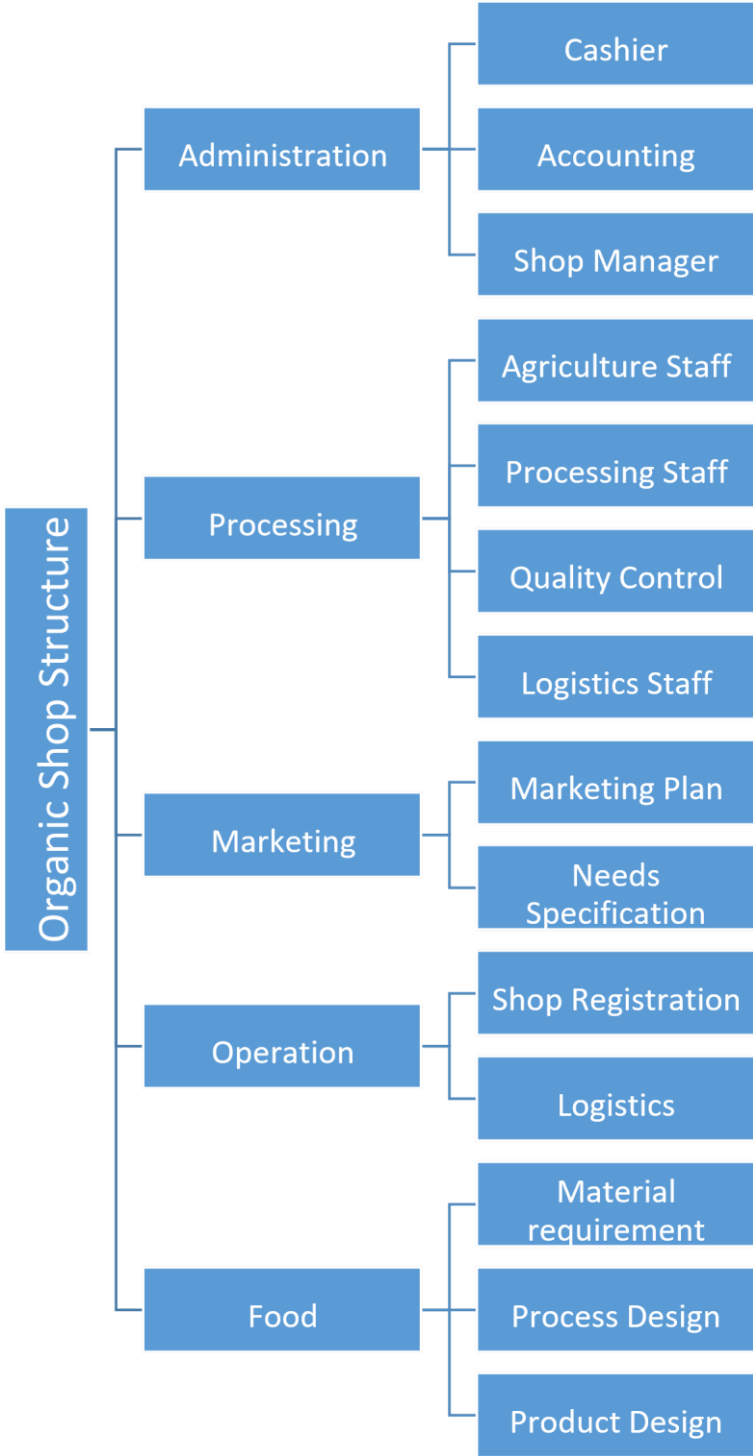

Thailand high speed railway

Thailand is planning to establish a high speed railway to connect Bangkok to Chiang Mai in the north of Thailand. They are negotiating with a Japanese company to build this railway. However,

the prime minister, gen Prayut wants the project to be cost efficient and does not want the train tickets to exceed 1200 baht. The estimated cost of this project is 100 billion baht. You are asked as a project consultant whether this project is viable or not.

The underlying 252-km leg interfacing the Thai capital, Bangkok, and the northeastern area of Nakhon Ratchasima will cost of 179 billion baht (\$5.85 billion) for the chief stage, with China liable for presenting systems, plan and the acquisition of trains, an organization video conveyed to journalists showed up.
